RE: 2014 QAP Comments

Dear Scott, Chris and Mark,

It is our understanding from the recent NCHFA QAP question and answer session that additional grocery stores can be proposed to be added to the QAP's approved grocery list.

I am glad that you are open to adding additional stores since it is crucial for North Carolina's established neighborhoods that they have access to the tax credit dollars which are created by adding a new tax credit property. This works both ways, in that, the established locally owned and operated grocery stores get new customers and the tenants get access to affordable food.

The major chains have moved to ever bigger stores which just don't fit into established neighborhoods, leaving behind empty or underutilized stores which are a frustration to mayors of cities across this state. This is very apparent in places like downtown Raleigh and Winston Salem where the big chains have closed stores and positioned themselves three miles away where they have the space to build the modern supermarkets as they follow the profits of selling sushi, premade foods, and other high margin products.

Here in North Carolina there has been a big push to create and keep jobs here in North Carolina through the tax credit program. Supporting our locally owned grocery stores and the other neighborhood shops that benefit from the new residents created by new tax credit properties should be included in that emphasis.

With that in mind, I am proposing that Fred's Food Club be added to the approved list in the 2014 QAP based on the below information. For comparison purposes, I have compared it with Trader Joes which is on the approved Grocery Store list.
